#### Certification

All participants will be awarded with Certificate in WSH upon meeting 75% of the required course attendance for each module and assessed to be competent.

#### Assessment mode

Each module will be assessed individually upon completion of per competency unit through a combination of written assignments, case studies, oral interviews or written projects. All participants must achieve at least 75% physical attendance per module to be eligible for the assessment.
